To that effect, the Executive Secretary has approved that all organizations, companies and churches who are licensed as service providers to the Nigerian Christian Pilgrim Commission, as Air Carriers, Ground Handlers and Christian Pilgrimage Operators, whose licenses have expired be invited to renew same within the next three (3) months, by paying the arrears of the licence fees. Any organization that fails to renew its licence for two (2) consecutive terms would be deemed dormant and liable to be struck out of the list of service providers with the Commission. Such an organization would be required to apply for a fresh licence whenever it wishes to resume pilgrimage activities.
